Your personal data will be stored under strict confidentiality and may not be used for purposes other than those stated, unless this Privacy Notice is amended.

You have the right to exercise your **ARCO rights** (Access, Rectification, Cancellation, and Opposition). To exercise any of these rights, please contact the data controller, **L.C. Your request must include the requirements stated in Article 29 of the law:

- 1. Name of the data subject and address or another means to communicate the response to your request.

- 3. A clear and precise description of the personal data for which you wish to exercise your rights.
- 4. Any other element or document that facilitates locating your personal data.

All processing times begin once the request is acknowledged by company stamp or email confirmation.

CASTILLA is not obligated to cancel personal data when it falls under exceptions defined in the law, including but not limited to: when related to private, social, or administrative contracts and necessary for their fulfillment; when processing is legally required; when cancellation hinders legal or administrative actions related to taxes, criminal investigations, or sanctions; when required to protect legal interests; or when fulfilling a legally acquired obligation.
